

#### Individual



#### Who will I interview with?

- Admissions Rep/Dean
- Alumni
- Recording



### Common Interview Questions

- Why do you want to be a lawyer? / What do you hope to do with your JD?
- Why are you interested in X type of law?
- Why are you applying to law school now?/ Why are you switching careers?
- What interests you about our school?
- Tell me about a time ...
  - you were challenged while working on a team.
  - you showcased leadership.
  - you overcame an obstacle.
- What have you learned at your current job?
- Talk to me about [the hobbies or interests you listed on your resume].

# Questions that ask for you to reveal weaknesses/struggles

- Describe a time when you struggled academically and how you responded to that challenge/Name a time you failed and how you handled it
- Tell me about a time you showed resilience
- If you worked in law school admissions, what would you describe as your biggest weakness?
- What is something that you think differently about or has changed about you personally as you have matured?

## Questions asking you to talk yourself up

- What is your greatest success story?
- Who is my best friend, and how would they pitch you to the admissions committee?
- Give a fun fact about yourself

#### Questions about the law school

- What are the pros and cons of this law school?
- Is this school your top choice?
- As someone who's based in the Midwest, what's enticing about moving out to [location]?
- What club(s) at our law school would you join?

#### Issue Based Questions

- Debate Pokemon Go and the issue of whether players are trespassing
- What do you think of the Burka ban in France?
- The ABA is considering a uniform bar exam. Good idea?
- Here are a few sample admissions scenarios. Would you admit this student? What would you give them on a scale of 1-10 and why?



### How to Prepare

- Research the School, including Clubs
- Prepare Questions to Ask an Interviewer Ahead of Time
- Research the Area & Prepare a Reason to Move There
- Practice your Elevator Pitch
- Prepare content like a book you can talk about, a social issue you changed your mind on, and have a few really good anecdotes you can tell for "Tell me about a time when" questions
- Practice having someone ask you these questions
- Dress Business Casual (including what they can't see on camera)
