## **DRIVING DIRECTIONS TO UNION SOUTH:**

### **To Lot 80 (Union South garage):**

#### From the Madison Airport:

1. Exit the rental car lot onto International Lane;
2. Turn left onto Packers Avenue when International Lane ends;
3. Packers Avenue becomes Pennsylvania Avenue then E. Johnson St. then E. Gorham St. then finally University Avenue;
4. Approximately 4+ miles after leaving the airport, turn left on N. Randall Avenue;
5. Cross over Campus Drive then turn left on W. Dayton St.;
6. The ramp for the Union South garage will be on your left.

#### From I-90 (North or South):

1. Exit at US-12 W/US-18 W/W Beltline Hwy;
2. Take the US-151 N/Park Street exit, EXIT 261;
3. Turn right onto Park Street;
4. After approximately 3 miles, turn left onto W. Dayton Street;
5. After traveling through one traffic light, Union South will be ahead on your right, near the end of W. Dayton Street, just before the intersection of W. Dayton Street and N. Randall Avenue.

#### From Baymont Madison West:

1. Head South toward Excelsior Dr
2. Turn left onto Excelsior Drive; Continue on Old Sauk Rd
3. Merge onto University Ave/ Campus Dr to W Dayton St
4. Turn left onto W Dayton St; Destination will be on the left

## **Law School Expo Parking Information: University of Wisconsin-Madison**

- I. Basic Parking Information for the Law School Expo
  - A. **Parking will no longer be organized by the MAPLA caravan site coordinator. You will need to obtain a parking pass well ahead of the event.**  
The following guide is designed to help you obtain a parking pass.
  - B. If you intend to park at the Law School Expo in UW-Madison, you will need to reserve an on-campus parking permit. By purchasing a permit you are guaranteed a parking spot on campus in a specific parking garage or surface lot.

### III. Locations

A. **Lots 17 and 80 are the lots that are closest to the Law Expo location in Union South. Lot 20 can also be used.** They can be searched as the following:

1. Lot 17 (Engineering Drive Ramp)
2. Lot 20 (University Avenue Ramp)
3. Lot 80 (Union South Garage)
  - a) For surface parking lots 17 and 20: **The permit must be hung on the vehicle's rear view mirror with the lot number facing out.**
  - b) You will have to scan the permit at the parking garage entry and exit.

**(1) If the "Lot Full" sign is lit, you should still proceed to park in the lot.**
